Introduction

2022 to 2023 was a year of extensive political, environmental, economic and social change. It continued the trend of unprecedented concurrent impacts on Australia's economic and social environments. As noted in the RDA Logan and Redlands 2022 to 2023 Business Plan and Budget (against which this report is based), this has included:

- instability in geo political conditions;
- fires;
- floods;
- drought;
- an enduring pandemic;
- changing work practices;
- a growing call for and reliance on publicly funded bail outs; and
- heightened internal migration.

Sitting across this has been the roll out of the incoming Australian Government's agenda including through the Government's 2022 to 2023 Budget released on 25 October 2022 and 2023 to 2024 Budget released on 9 May 2023.

While the impact of some of these has lessened, the changing world has had and continues to have major impacts on the Logan and Redlands Region which demands attention be given to this often overlooked Region. Rather than a continuing reliance on "resilience" there must be a focus on ensuring opportunities arising are taken up and challenges are addressed. This requires leadership.

A snapshot of headline data from the Logan and Redlands Region is as follows:

The Redlands' inhabited islands comprising North Stradbroke, Coochiemudlo and Southern Moreton Bay islands collectively house over 10,500 residents, facing similar but unique challenges of infrastructure, unemployment and services.

Similarly, the Greater Flagstone and Yarrabilba Priority Development Areas (in between which sits Jimboomba) have similar economic and socially contextualised issues.

Against this backdrop the RDA Logan and Redlands (the RDA) Board's focus is on longer term (20+ years), strategic enabling issues. This reflects the RDA's role is not to duplicate or compete on specific local initiatives but rather to identify and advocate on behalf of the Logan and Redlands Region and the broader South East Queensland Region on key areas of focus to avoid building in failure factors resulting from a myopic approach to planning (e.g., with increased population and traffic there will be a need for better and more expansive planning for increased mobility, health, education, cultural, sport etc facilities and supports).

As a key activity for the RDA in pursuing this focus, the RDA's 2022 to 2023 Business Plan includes:

Over the period July to December 2022 the RDA will complete the development and launch of the Logan and Redlands Strategic Regional Plan. Concurrently, the RDA will hold a major regional investment Summit in September 2022 with participation from the Commonwealth, Queensland and Logan and Redland Local Governments, Economic Development and Investment agencies, businesses, chambers of commerce and community and cultural groups.

This was a critical goal in testing the RDA's interpretation of intelligence gathered through extensive stakeholder engagement built off the back of the RDA's October 2020 release of its initial Strategic Regional Plan Logan and Redlands: The Centre of Economic and Employment Growth for Queensland (available at

https://rdaloganandredlands.org.au/images/documents/Logan-and-Redlands-The-Centre-of-Economic-and-Employment-Growth-for-Queensland-2020.pdf).

It was with great pride the RDA hosted the *To 2042 and Beyond : Investing in SEQ* Summit on 29 September 2022. Reflecting the extensive consultations and the RDA's commitment to the long term, the event considered a broader South East Queensland context in addressing impediments to and opportunities for regional economic growth. Underpinning the Summit was the position of the RDA that while the key events such as the SEQ 2032 Olympics and Paralympics provide great incentive for regional investment, it is necessary to ensure the legacies extend well beyond 2032.

Details of the Summit are available at https://www.summit2022.rdaloganandredlands.org.au/. The Summit is provided as one of the two case studies included in this 2022 to 2023 Report on Outcomes.

The aim of the Summit was broadly to engage decision makers and funders in a 20+ year vision. The closure of the Summit noted:

- it had heard directly from businesses, been exposed to current research and had a chance to meet and discuss issues impacting the Logan and Redlands and broader South East Queensland regions;
- the RDA Logan and Redlands Board sees a clear mandate to take forward a commitment to
 progress the concepts and ideas that were raised at the Summit and to ensure this process
 continues to gain traction and momentum amongst regional stakeholders; and
- in parallel the RDA will bring to a conclusion its development of this Strategic Regional Plan which will be substantially enriched as a result of the Summit and reflect the need for cohesive, co-ordinated and long-term strategic regional planning

Taking the outcomes forward has been within the 4 identified themes arising from the Summit being:

- Economic Infrastructure;
- Social Infrastructure;
- Education, Skills and the Labour Market; and
- Leveraging opportunities including amenities.

The RDA's identified themes are consistent with the Australian Government's revised RDA Charter (available at https://www.rda.gov.au/sites/default/files/documents/rda-charter.pdf), Regional Investment Framework (available at

www.infrastructure.gov.au/sites/default/files/documents/regional-investment-framework-july2023.pdf) and key regional priorities (available at https://www.rda.gov.au/sites/default/files/documents/priorities-matrix.pdf).

Aligned with and following the Summit, RDA Logan and Redlands continued developing a revised Strategic Regional Plan which built on the document 'Logan and Redlands: The Centre of Economic and Employment Growth for Queensland' released by the RDA in October 2020.

In parallel, the RDA concluded its development of a Strategic Regional Plan which was substantially enriched as a result of the Summit. This Plan reflects the need for cohesive, coordinated and long-term strategic regional planning.

The development of the Strategic Regional Plan included revisiting the RDA's earlier strategic document, *Logan and Redlands: The Centre for Economic and Employment Growth*; planning for and the successful conduct of the Summit; and greater penetration through the expansion of the RDA's stakeholder engagement strategy.

Over the past 2 years consultations have included aligning the RDA Board's bi-monthly meetings with stakeholder round tables including with local businesses, employment intermediaries, education and training providers, Councils, Queensland Government State Departments, Members of the Australian and Queensland Parliaments and community groups. This included holding meetings on the islands off the Redlands mainland.

The development of the Strategic Regional Plan was substantially enriched as a result of the Summit. In closing the Summit, Mr Hardgrave again thanked those attending and presenting at the Summit acknowledging without their support initiatives such as the Summit and its capacity to drive change to reflect current and emerging opportunities with the intention of challenging conservative and competitive approaches to planning for the Region would not be possible.

The development and validation of the Plan included seeking and receiving comment on the draft Plan on a confidential and without prejudice basis. All comments received were of value and indicated general support for the Plan and its contents.

The strategic planning lays out the long-term, broad goals to be achieved. The tactical planning dominates the 2023 to 2024 business plan which outlines the short-term steps and actions to be taken to achieve the goals of the Plan.

The RDA Logan and Redlands (the RDA) Board's Strategic Regional Plan *Logan and Redlands:* Challenges and Opportunities for Sustainable Growth was released in February 2023 and is available at https://rdaloganandredlands.org.au/images/documents/Strategic-Regional-Plan-February-2023.pdf. The release of the Plan reflects the need for cohesive, co-ordinated and long-term strategic regional planning.

The Strategic Regional Plan has been broadly supported across all levels of government, the private sector and the wider community.

This is not to claim everyone participated in consultations nor the content of this Plan is universally supported. To have achieved these twin outcomes is implausible. However, the consultations did unearth key deficiencies in current planning generally and specifically for South East Queensland.

It is an unfortunate reality competition dominates cooperation. There is an element of some interested parties whose key question is "what is in it for me?" People who do not live in the community are having a greater say over the community than its residents particularly in peri urban regions distracting attention from key local issues.

In general, peri urban refers to areas beyond the metropolitan fringe, at the interface between city and country but within the economic and social catchment of a large metropolitan area – an apt description of the Logan and Redlands Region.

This is not to suggest the region exists in isolation. However, while regional planning and decision making remains insular and parochial rather than broad, driven by self interest and characterised by obstructionist behaviour, the necessary vision for the South East Queensland Region to Attract / Invest / Sustain at a level where synergies are maximised will continue to be stunted. As has been attributed to Einstein, "The definition of insanity is doing the same thing over and over and expecting different results". A better approach is needed.

While outside the timeframe of this 2022 to 2023 Report on Outcomes it is within this context the RDA welcomes the 24 August 2023 release of the Australian Government's 2023 Intergenerational Report which projects the outlook of the economy and the Australian Government's budget to 2062 to 2063 (available at https://treasury.gov.au/publication/2023-intergenerational-report).

The Context


In challenging the thinking around planning for the Region, whether Government or Private, it became clear throughout 2022 to 2023 the language needs to be about investment and therefore recognise the importance of Return on Investment (ROI) in decision making. With past planning being based on "cost" rather than investment, inadequacies have been identified as population growth and related impacts occur. The result has been additional upgrade and maintenance costs which would have been mitigated through an initial "investment" planning model.

The strategic challenge is to make sure the current and future pipeline of activity across the Logan and Redlands Region is not stifled, does not fail to deliver as expected and/or is not as sustainable as should be the case due to the surrounding environment not being considered and planned. It is this role the RDA pursues in its commitment not to duplicate or compete on specific local initiatives but rather to identify and advocate on behalf of the Logan and Redlands Region and the broader South East Queensland Region.

While the Logan and Redlands Region is positioned to capitalise on the substantial economic, social and environmental opportunities across the 4 themes identified in the Strategic Regional Plan, this potential is hindered by, amongst other things, vulnerable supply chains, inadequate mobility corridors and limited skilling and training opportunities.

To capitalise on the Region's economic advantage and population potential, access to training, infrastructure and investment should be prioritised. The Strategic Regional Plan highlights investment in essential infrastructure crucial to support the Region's growth. The increasing need for public and private investment across South East Queensland highlights the need for strategic leverage of opportunities to achieve economic and social advancement.

The Australian Government has widely disseminated the following representation of the implementation of the Regional Investment Framework through the Budget cycle.



Abridged RDA Logan & Redlands Annual Report on Outcomes 2022 to 2023

The Australian Government has charged RDAs with supporting the successful implementation of this Framework, which will guide a coordinated approach to regional development, underpinned by local engagement.

The taking forward of the Strategic Regional Plan has been recalibrated to operate within this cycle noting the 4 themes of the Strategic Regional Plan are:

- Economic Infrastructure;
- Social Infrastructure;
- Education, Skills and the Labour Market; and
- Leveraging opportunities including amenities.

These themes are aligned with the Australian Government's Regional Investment Framework and Regional Priorities as follows:

The Engagement

As a headline issue, priority expenditure in outer suburbs is per capita lower than inner city areas, but in addition, road and rail transit corridors in and around the Logan and Redlands Region have been about "passing through" rather than "getting around" the Region. In short, infrastructure expenditure needs to better match the needs of the Region to unleash its strategic importance to economic and employment growth, social cohesion and environmental sustainability.

It is within this environment the RDA continues to pursue its determined corporate goal of ensuring the Logan and Redlands Region will be at the centre of economic and employment growth for South East Queensland, Queensland statewide and Australia wide. It seeks to do this collegiately.

To ensure the RDA has been able to maximise opportunities for input to the development of the Logan and Redlands Strategic Regional Plan, an ambitious and extensive consultation process was put in place immediately following the release of *Logan and Redlands : The Centre for Economic and Employment Growth* in October 2020. Engagement was sought with:

The use of Facebook has continued to increase over the 2022 to 2023 period. A LinkedIn account has been established for the RDA.
